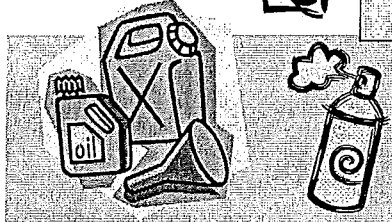

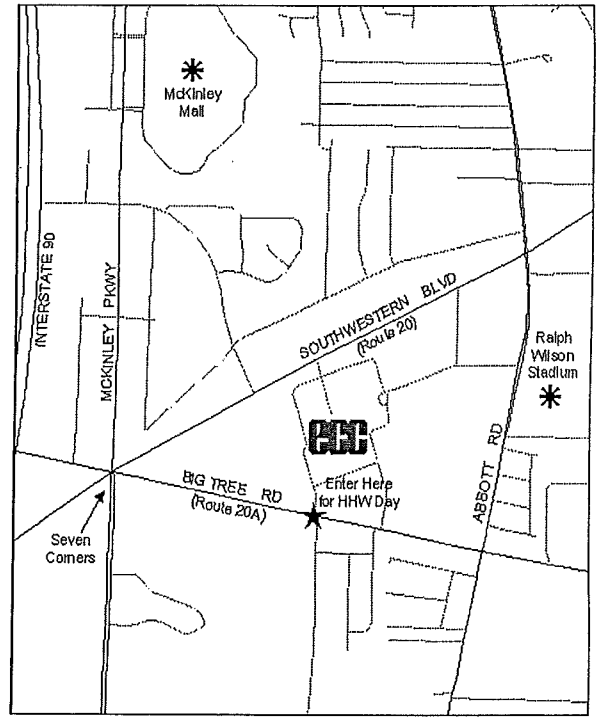

- ◆ PESTICIDES, FERTILIZERS, POOL AND HOUSEHOLD CHEMICALS/CLEANERS -limit 2 gallons or 20#
- ◆ OIL-BASED PAINTS, SPRAY CANS -limit 10 gallons
- ◆ OIL, GASOLINE, KEROSENE, ANTIFREEZE-limit 10 gallons
- ◆ PAINT THINNER, STRIPPER & SOLVENTS-limit 2 gallons
- ◆ BATTERIES - lead acid & rechargeable
- ◆ MERCURY - thermometers, thermostats, metal
- ◆ PROPANE TANKS & CYLINDERS - full or empty
