Meeting called to order at 7:30 p.m. New member, Rob Lewis, was welcomed and introduced to board members.

I. New Business:

- A. Paul Ernst request for variance.** The Planning Board was notified by the Zoning Board of Appeals of a request by Mr. Paul Ernst of 7005 Olean Road, Holland, NY for a variance to allow erection of a 2+ car garage 0 feet from the south lot line. After discussion, the Planning Board felt that it did not have enough information to offer comments and/or a recommendation to the Zoning Board of Appeals regarding the request for a variance.
- B. Code Book Review –** The Town Board intends to review/revise Holland's Code Book in the upcoming months. Planning Board members are asked to make note of concerns they may find within the Code Book and present them for discussion at future Planning Board meetings, or directly to Karen Kline who may propose to the Town Board. Scott Hess, Code Enforcement Officer, joined the meeting briefly and described his confusion with definitions in the Code Book, specifically the definition of "dwelling." Mr. Hess needs to clarify the definition of dwelling as a town resident is requesting to construct an additional dwelling on a lot currently owned and whom already has one dwelling on the property.

II. Old Business:

A. Julie Smith- Request for review of 10 acre lot size for farm animals.

Several Planning Board members reported on the findings from research and information gathered from neighboring towns regarding their codes with regards to acre lot sizes for farm animals. For example: Town of Concord requires 4+ acres; Town of Aurora requires 5+ acres; Town of Orchard Park requires 5+ acres; Town of Arcade requires 10+ acres.

Marty Regan will put together a table with this, and other information gathered from neighboring towns for review at the March Planning Board meeting.

III. Meeting adjourned at 8:30 p.m. Next meeting - Wednesday, March 6, 2013.
