SCRAP TIRES

Problem with commercial establishments putting their tires up at the highway building. The town gets charged \$.65 per passenger tire and \$4.00 per tire for heavy duty tractor tires. The town started doing the tire drop-off for the purpose of not having tires in ditches etc. The town is going to start charging these commercial establishments. A sign will be made and a Local Ordinance put into effect.
